Preparing your bike for winter

When examining your bicycle, it is always a good idea to start with the handlebars and work your way down to the rear wheel.

What you should check for is basically that all the moving parts function properly, no faulty sounds are heard and no backlash is experienced.

Backlash is checked by observing and feeling whether parts are staying fixed while they can still be turned. If they can, there is backlash.

While checking the bicycle and finding parts that are not properly attached, you should tighten them. If they still do not seem to be properly attached, you should consider purchasing new parts for your bicycle instead.



Next, check if the brakes work and whether the mandatory reflectors are mounted.

While on the subject of reflectors, you should check your lights before the darkness of winter arrives.

If you do not already have lights and know that you will be needing them, I can recommend the magnetic light type. They are incredibly practical since you do not need to turn them off, and they are not easily stolen.

Then, you should check your tires. Check the air pressure, and check for wear. They are worn if there is no track left on the tire, or if holes are found. If that is the case, my advise is to purchase a new pair of tires. It is also a good idea to check the tires for water. Lastly, you should grease the chain, pedal and crankset.

Re 1) Thomas C22 is chosen as moderator and Danish is chosen as language for the meeting.

Re 2) 10 voting members are present.

Re 3) Minutes of the last residents' council meeting approved

Correction to item 8B: The DKK 10,000 that Planenergi require to produce a report is BEFORE VAT.

Re 4) Agenda approved

Correction to item 8D: The amount spent on paper is BEFORE VAT.

Re 5) Economy

NYK's account holds DKK 127,000 and the network account holds DKK 184,000.

Annual financial report from NYK: See appendix to the notice. The disposable balance per November 1st, 2012 is DKK 127,785.05. A total income of DKK 215,218 has been registered along with expenses of DKK 254,003.05, giving a difference of DKK -38,785.05.

From NYK's account, DKK 12,000 has been paid to the Nybro FC men's team for referee fees. DKK 1,000 for Green Dormitory and the outstanding amount from NybroFestival has been deposited. Salaries have not yet been paid.

DKK 291,000 from the network account has been used to settle two loans, DKK 32,000 for salaries, and next month DK 50,000 will be used for equipment.

Re 6) Announcements

Constituent network meeting will be held on the evening of Thursday, November 8th, 2012 – a notification was made at the last meeting. It is still possible to come along by contacting Jonas D59.

Information regarding the athletics field: A new quote will be necessary – since the old one is outdated – before funds are applied for, and it is expected to be finished in the summer of 2013.

Re 7) Board meeting

There is a board meeting Wednesday, November 5th, 2012 – the agenda has not been received yet.

Re 8A) KælderCaféen's financial report from 3rd quarter 2012.

See appendix to the notice. The report is for the period July 1st, 2012 – September 30th, 2012. An income of DKK 94,791.56 has been registered along with expenses of DKK 86,795.69, giving a difference of DKK 7,995.87.

The current difference for the year is DKK -17,732.34.

With the profit from last year, KælderCaféen still has a balance of around DKK 16,000.

Re 8B) Use of KælderCaféen by the dormitory's clubs.

A vote will be held to decide whether the dormitory's clubs can use the facilities for events such as the Cake Festival with no alcohol involved: There should be no limit on the number of events or the time of day, as long as a bartender is present at all times.

For: 8

Against: 0

Abstain: 2

The proposal is approved.

A vote will be held to decide whether the dormitory's clubs can use the facilities for events with alcohol involved. The bar can only be used on Saturdays and the party stays closed the entire evening. This can occur once each month.

A limit to the opening hours would have to be decided for these events.

A consideration is needed as to why these rules were imposed to begin with: to accommodate the residents of the J-K block – and for them, the

difference between a private party and a club party is nonexistent.

For these events, residents must be informed how many guests will join the party. This way, it will be easier to communicate with JK and others about how the party can be as comfortable as possible - both for guests and potentially annoyed neighbors. It is easier to inform guests about rules when a dormitory club is having the party.

The proposal is approved.

Re 8C) Solar panel system.

The system should not exceed 1000 square meters, which enables possibilities for both solar heating and solar panel systems. However, there is not enough room inside for a boiler tank, making it necessary to apply with the municipality for permission to build an outdoor tank. The dormitory is already using the full plot ratio, which could make it difficult to gain permission to build an outdoor tank. It must be built above ground because the dorm is too close to the lakes to allow for building below ground.

Contact to several companies has been made regarding the solar panel system, one of which offers a free work quote and the other – like Planenergi – requires payment for a quote. If we are to install solar panels, the roof will be covered with them, since they are more effective when lying down – it will also be possible to install them closer together. Because of this, the roof will need to be replaced. This is an expense that has already been anticipated and will be covered by the dormitory, and no extra expenses will be applied to the residents.

If anyone has questions, they are urged to contact Mikkel J21 or Claus C18 before the next meeting, so they have a chance to research the questions. The plans regarding the solar panel and solar heating systems will be presented at the next

residents'- and residents' council meeting in December, where everyone that can is urged to attend.

Re 8D) Purchase of paper for NybroTidende: Paper for DKK 5,000 has been purchased for NybroTidende from the Network account. Should the Network Group pay for this or should the residents' council pay for this?

Residents' council pay: 5

A new construction permit will be applied for. This costs around DKK 4,000. The amount will be deducted from the earmarked funds.

KælderCaféen has seen some organizational changes, which have been announced in the minutes of the general assembly. The position of daily manager has been abolished, and all of the position's responsibilities have now been distributed to a committee. Two new members have been appointed to the board.

It is regrettable, that this was not discussed among the residents' council before the changes were made.

Flyers have been distributed in mail boxes stating that the general assembly was cancelled, but no information was given that it would be conducted

after all. This has been a problem for residents who wished to participate but were not aware that the general assembly was being conducted. The board has not had anything to do with these flyers, and did not know that they had been passed around.

Even though the statutes no longer state that only a person over 25 can obtain the alcohol permit – and this is still true according to applicable law – it would be advisable to leave such an item in the statutes, so future management boards are aware of this.

The items that were approved by the general assembly have been approved and the general assembly was valid. The general assembly's changes to the statutes are urged to be discussed at the next residents' council meeting, so everyone has a chance to participate in the discussion.

Regarding notices and minutes of the general assembly: These should be sent out by the "alle_beboere" e-mail instead of the mail boxes. This will be discussed at the next meeting. A social-mail address could be established to which all clubs – including KælderCaféen – can send e-mails to.

There have been problems with loud music at the beginning and the end of the nights when KælderCaféen is open, which has caused noise to be heard in JK and other places nearby, urging the bartender group to show more consideration in the

future.

A mobile phone is requested in KælderCaféen, which would make it easier to respond to complaints from residents. Many others will be asking for mobile phones when the possibility of calling external numbers from the dormitory's central telephone system is gone. The places where a telephone is necessary must be taken into consideration, when it is no longer possible to call external numbers.

The residents' council, Nybrogård Kollegiet order of business is referred to, where according to § 4 item 2, it states: "A member, who twice within 6 months refrains from attending a residents' council meeting without prior notice to the secretary, is automatically resigned from the residents' council".

Re 11) Next residents' council meeting will be held on Monday, December 3rd, 2012 at 20:00 in the GH-basement. Residents' meeting/general assembly will be held at 19:00. A notice will be sent out by e-mail three weeks before the general assembly and another notice 10 days before each meeting.


How do you get a garden and what do you need?

Worried about mildew and mould?

No matter how great your hospitality, mould would probably not be a buddy you would want to invite into your dormitory room.

Just as the winter sets on, there is a tendency for people to start venting out less, turning up the heat and hang-drying clothes indoors.

On behalf of the inspector, we would like to warn you about mould, that under these conditions obtains optimal living conditions in the dormitory rooms.

Mould can be difficult to notice, since it is not always visible. It can grow on any organic material, such as wallpaper, fabrics and plaster boards. Other symptoms of mould are the discomforts that the resident suffers.

If you suffer from constant headaches, trouble breathing or ailments of this nature, do not be afraid to inspect your room. Especially behind furniture blocking an outer wall, since these will typically be colder than an inner wall.

What you want to avoid is cold and moisture. You should consider whether it is necessary to hang-dry your clothes indoors or if you have other available methods.

If you should encounter mould, contact the inspector at once. Small outbreaks can luckily be cured with a little elbow grease and Rodalon.

Good advice for prevention of mould:

- Vent out the room several times a day — especially bathroom, kitchen and bedrooms.
- Turn on the stove fan or open a window while cooking.
- Close the door to the bathroom while bathing.
- Do not hang-dry clothes inside.
- Keep embedded window vents open.
- Fix small water damages quickly and remove the source of the damage.
- Vent out more when the heating season starts to remove the summer's moisture.

What does it mean, being a member of the board?

The residents' meeting on December 3rd is approaching fast. At the meeting, among other things, it will be decided who will represent the dormitory's residents in the board in the coming time.

The residents' current representatives, Camilla Sogaard Elbert, L1 and Andreas Brask Andersen, D52 have both announced that they will retire at this election. Two new representatives will therefore be needed — one for a one-year period and another for a two-year period.

But what does it mean, being a member of the board? What kinds of duties do you take on? How much time do you spend on it? Are there many meetings? And do you have to meet certain demands in order to be elected? We asked Camilla Elbert these questions!

As the residents' representative you are the board's eyes and ears at the dormitory. The rest of the board rarely visits the dormitory, making it the representatives' most important task to act in the residents' best interest.

Much of the time invested in the job as a board member is allocated to researching the basis for exemption applications. This is not the full job, but it is a large part of it, and you should be prepared for that. Besides that, the job entails negotiating and approving budgets, financial reports and other items KAB puts on the agenda at the board meetings.

There is a total of three board meetings that are sure to be held each year, and where participation is mandatory. These are held in April, October and December. Each takes about 3 hours and they are often held close to the dormitory.

Customarily, the meetings in April and October are held at Nybro Kro, while the meeting in December is held at KAB in Copenhagen.

When you are elected in to the board as a representative of the residents, your role is not finally decided. Regardless of this, the two representatives are often elected as chairman and deputy chairman at the constitu-

ent board meeting in December. The reason for this is, that in many situations, the board can only act on the chairman's signature. Since this signature must be on all the exemption applications, it is very convenient that the chairman is a resident of the dormitory. If neither of the two representatives wish to be elected chairman, this can also be arranged — it will just mean more administrative work for the board as a whole.

If you are elected chairman, you will once in a while receive a phone call from a person or company with a quote or a question. This should not alarm you. Camilla can assure that answers can always be found either within the board or from KAB, if you are in doubt about anything.

Besides that, it is always advised to ensure cooperation between the two representatives. That way, it will be possible to split work loads and responsibilities during your more and less busy periods.

In order to be elected, as a member of the board for the coming term, all you have to do is show up at the residents' meeting on December 3rd. The meeting will be held in the GH-basement at 19:00.

You are expected to remain a resident for the whole term. Of course, situations can occur that alter your plans, but it is expected that your current plans are to remain a resident.

There are no requirements to your level of education, skills or interests, but you are expected to take on a discussion when necessary and you should always be willing to voice your opinion even when you know that it is against the majority's. You should be prepared to work for the cause for at least a year, and engage yourself in the dormitory and its concerns.

If you are interested, show up at the residents' meeting and help out the dormitory!

5 quick questions for Camilla:

Which tasks are you expected to solve as a board member?

The most common task as a board member is reviewing the mant applications for exemption that are sent to the board. The majority of these application deal with extension of rental contracts and dispensation to sublet.

How much time do you spend each month?

It is difficult to say how much time I spend each month, since it can vary greatly, but to be on the safe side, I will say that you should be prepared to spend 8 hours each month.

Is the time distributed on tasks you can control yourself, or are there certain times, you have to be available?

Being a board member is a very flexible job. There are no fixed hours you have to be available other than the agreed meetings.

How many meetings are there?

There are 3 meetings each year. One in April, October and December. The meetings usually last around 3 hours. The meetings are held with the other board members and other relevant persons from KAB.

Is formulating capacity, economic sense or anything else necessary in order to be a part of the board?

It is always a good idea to be well formulated. That just gets you fart-hest. But besides that, you do not need to be anything special to be part of the board.

The Hobbit — An Unexpected Journey

A decade has almost passed since we saw The Lord of the Rings roll out across cinemas the world over. On **12.12.12**, the cinemas open once again, this time for the first of three films about the preceding story better known as "The Hobbit".

The Lord of the Rings and The Hobbit share their background with the books of the same names written by J.R.R. Tolkien. They are also all directed by Peter Jackson of New Zealand, who again brings to life what is expected to be a true big-budget film, or rather a big-budget trilogy.
